Announcement Home Care Service of NSW transfer to Australian Unity in early 2016

Minister John Ajaka announced on 28 August 2015 that <u>Australian Unity</u> would be the new operator of the Home Care NSW. This was the first step in the transfer process for services and supports currently provided directly by FACS. The NSW Government is aiming to finalise the transfer of Home Care by early 2016.

There will be no changes to the services clients receive. Under the agreement Home Care staff and clients, including Aboriginal Home Care will transfer to Australian Unity and services will continue to run as normal now and after the transfer.

Is de-concentrating social housing a useful policy to promote wellbeing?

Sharon Parkinson, Elizabeth Taylor, Melek Cigdem, Rachel Ong | Australian Housing and Urban Research Institute.

A key assumption behind area-based policies such as urban renewal and 'tenure mix' is to foster greater 'social mix' of communities to offset adverse consequences of concentrations of social disadvantage. This project sought to use statistical techniques to identify whether concentrations of social housing, diverse tenure mix or type or density of dwellings has effects on social wellbeing. - See more at:

 Mental wellbeing and satisfaction with safety is lower in areas with high concentrations of social housing ar
more diverse tenure mix compared to those where they are less diverse. However, the chances of being
employed are <i>higher</i> in such areas.

□ Lower income private renters are less happy or satisfied with their safety in areas that are more diverse and
have concentrated social housing, and have lower chances of being employed in areas with high social housing.
This contrasts with higher income renters who tend to be happier and more likely to be employed in more diverse
areas.

□ Social renters are happiest, more satisfied with safety and have higher chances of being employed when they reside in moderately mixed areas (i.e. neither predominantly home owning nor highly mixed or with high social housing). Their happiness is lower in higher density dwellings.

Hear our voices:

Submission to the Senate Inquiry into current levels of access and attainment for students with disability in the school system, and the impact on students and families associated with inadequate levels of support

It is the view of Children with Disability Australia (CDA) that the current education system in Australia is failing to adequately meet the needs of students with disability. It is recognised that some students with disability have positive education experiences with good academic and social outcomes but this is by far the exception.

The breadth of disadvantage students with disability must contend with in the current education system is profound. At CDA we are inundated with reports of poor and shameful education experiences. A typical school experience for students with disability involves discrimination, limited or no funding for support and resources, inadequately trained staff, a systemic culture of low expectations, exclusion and bullying. There are increasing incidents of restraint and seclusion reported to CDA, which are seen as a clear consequence of a system in crisis. Failings have become entrenched in the education system and the urgency of delivering system wide solutions is now acute.

It is hugely concerning that no meaningful reform regarding education provision for students with disability has occurred to date. The common education experience of students with disability is poor, at times harmful and definitely not providing these children and young people with the skills, knowledge and confidence to be able to contribute meaningfully to our community post school. The education system is unacceptable for students with disability. It is sincerely hoped that clear and coordinated action finally occurs following this Inquiry.

Disability Issues In The Media

Federal Court decision – Mulligan and NDIA (Legal Aid NSW News)

In Legal Aid NSW's first National Disability Insurance Scheme (NDIS) appeal, the Federal Court found for our client on both grounds of appeal. Our client, who has chronic ischaemic heart disease, an adrenal disorder and sciatica from two ruptured discs in his lower back, applied to be a participant in the NDIS on the basis of his multiple disabilities. His application to the NDIS was rejected on the basis that he did not have "substantially reduced functional capacity" to undertake activities in areas such as mobility, self-care and self-management.

He appealed to the Administrative Appeals Tribunal which affirmed the decision. He became the first person to take an NDIS appeal to the Federal Court. The Federal Court found that the AAT had failed to perform the task of review in that it had failed to address each aspect of our client's claim and had failed to give adequate reasons for its decision. The Federal Court has remitted the matter to the Tribunal to be reheard.

Disability Reform Council has recently endorsed a <u>pricing framework</u>, "*The Specialist Disability Accommodation Pricing and Payments Framework*" (the Framework) to guide the approach to producing benchmark pricing of specialist disability accommodation supports in the **NDIS**.

The vision of the Framework is to develop a sustainable specialist disability accommodation market to support choice and control, encourage innovation, and create certainty of supply and financial sustainability for governments, participants and providers.

The NDIA intends to undertake wide ranging stakeholder consultations in the first quarter of 2016 in order to finalise the benchmark pricing.

Rebuilding the village: supporting families where a parent has a disability

In Australia, and internationally, the family is recognised as the best environment for raising children wherever possible. Governments provide a range of universal and specialist services to support families. However, where a parent has a disability, particularly cognitive disability or mental illness, children are removed from their family at a rate many times greater than where parents do not have a disability.

A perceived dichotomy between the interests of children and their parents has most likely been built on erroneous assumptions about inherent parental incapacity, the lack of appropriate family supports, predictions of the likelihood of future harm to children in a risk-averse society and the priority given within the system to stability for children, thought to be found in permanent care.

Precedent for attributing intellectual disability to the reasonable person Supreme Court rules on the objective reasonable person test, when applied to a person with intellectual disability.

R v Thomas (2015) NSWSC 537

The client was a man with intellectual disability charged with unlawful and dangerous act of manslaughter after he punched his frail and terminally ill mother to the head resulting in her death.

He was found unfit and came before the Supreme Court for a special hearing. There was no doubt that the punch was deliberate, that it significantly contributed to the death of the deceased and that it was unlawful. The substantial issue was whether the punch was dangerous. The test is whether a reasonable person, that is an ordinary member of the community in the position of the accused, would have realised that the act was dangerous. This is an objective test and there had been no precedent for attributing an intellectual disability to the 'reasonable person'.

The Court's view was that in assessing whether the act was dangerous, it was unacceptable to judge the actions of a person with intellectual disability by the standards of the vast majority of citizens. The Court assessed dangerousness "upon a consideration whether a reasonable person possessed of a moderate intellectual disability rendering that person with extremely poor information processing speed and impaired conceptual reasoning abilities with knowledge that the deceased was weak and frail as a result of a debilitating illness would have realised that striking her to the left side of the face at least once would expose her to a risk of serious injury."

The client was acquitted of manslaughter and found on the limited evidence to have recklessly inflicted grievous bodily harm. The case establishes that the objective reasonable person test, when applied to a person with intellectual disability, should be a reasonable person with an intellectual disability.

Psychiatric disability support services

Information on specialist disability support services, provided under the <u>National Disability Agreement (NDA)</u> to service user's with <u>psychiatric disability</u> either as their <u>primary disability</u> or as an <u>other significant disability</u>. Unless otherwise stated, service user's with psychiatric disability include all service user's with psychiatric disability, regardless of whether it is considered a primary or other significant disability.

The information presented in this section has been extracted from the 2012–13 Disability Services National Minimum Data Set (Disability Services NMDS); comprising national administrative data on disability support services. The <u>data source</u> section provides further information on coverage, data quality, and other aspects of the Disability Services NMDS.

Key points

- About 84,000 people with a psychiatric disability made use of disability support services in 2012–13.
- Psychiatric disability was the second most frequently reported primary disability among people receiving residential disability support services.
- There was has been an average annual increase of 2.1% in the rate of non-residential service user's with psychiatric disability, between 2008–09 and 2012–13, while the rate of residential service user's decreased by an annual average of 2.5%.
- Employment services were the most frequently provided service group for non-residential service user's with psychiatric disability.
- Group homes were the most frequently used service type by people with a psychiatric disability receiving residential services in 2012–13.

• Indigenous Australians with psychiatric disability were about twice as likely to use both residential and non-residential disability support services as non-Indigenous Australians.

Residential mental health care

Residential mental health care services provide specialised mental health care on an overnight basis in a domestic-like environment. Residential mental health services may include rehabilitation, treatment or extended care. They are described in this section using data from the National Residential Mental Health Care Database (NRMHCD). The scope for this collection is all episodes of care in all government-funded residential mental health services in Australia, except those residential care services that are in receipt of funding under the *Aged Care Act 1997* and subject to other Commonwealth reporting requirements. The inclusion of non-government-operated services in receipt of government funding is optional, with 13 such residential care services included for the 2013–14 collection. For more information about the coverage and data quality of this collection, see the data source section.

- There were over 7,000 residential episodes of care recorded for over 5,200 residents in 2013–14.
- The number of residential episodes per 10,000 population increased by an average of 13% per year between 2009–10 and 2013–14. The estimated number of residents per 10,000 population increased by an annual average of 15% over the same period.
- Residents with an involuntary mental health legal status accounted for 18% of all episodes in 2013–14, compared with 29% in 2009–10.
- When principal diagnosis was specified, schizophrenia was the most common principal diagnosis for residents undergoing residential episodes of care (32%), followed by depressive episode (12%) and schizoaffective disorder (10%).
- The most common length of stay for a completed residential episode was 2 weeks or less (58%) in 2013–14, with 3% of episodes lasting longer than 1 year.

CHOICES Training supports the CHOICES in Aged Care project

The **CHOICES in Aged Care** project was a person centred, consumer directed care (CDC) approach to community aged care offering older people, and their carers, more choice, flexibility and transparency in directing their own unique care needs.

Additionally, the CHOICES flexible service model was developed for communities with distinctive needs: Rural, Regional and Remote; Culturally and Linguistically Diverse (CALD); and Aboriginal and Torres Strait Islander (ATSI) communities.

CHOICES evolved from the <u>People at Centre Stage (PACS)</u> model of flexible aged care which also informed Australian government aged care reforms.

Who was involved in CHOICES in Aged Care?

The **CHOICES** in **Aged Care** project was funded by the Australian Government, <u>Department of Social Services</u> <u>Encouraging Better Practice in Aged Care (EBPAC) initiative</u>, the Evidence Translation Projects Funding Round 3.

The research partnership between <u>UnitingCare lifeAssist</u> and the <u>Deakin University School of Nursing</u> that developed PACS continues with CHOICES.
