<u>Understanding the NDIS: a history of disability welfare from 'deserving poor' to consumers in control</u>

The National Disability Insurance Scheme aims to empower consumers with a disability to use funds given to them to purchase services that reflect their lifestyle and aspirations, writes Paul Ramcharan in The Conversation. The National Disability Insurance Scheme (NDIS) is the only national scheme of its kind in the world. Its introduction has been likened to a generational shift with some saying the scheme's impact will be similar to that of Medicare. Choice and control are the fundamental principles of the NDIS, which represents a break from previous welfare approaches. The scheme aims to empower consumers with a disability to use funds given to

them to purchase services that reflect their lifestyle and aspirations. It's hoped these changes will see the service sector reflect the interests of people with disabilities. Growth in community services driver of new institute

A dedicated research and teaching institute will be set up in Victoria to support growth in the disability and aged care sectors, the Victorian Government announced on Wednesday. The Future Social Service Institute is a collaboration between the Victorian state government, state peak organisation Victorian Council of Social Service and RMIT University. The state government is providing \$500,000 in seed funding, which will be matched by RMIT. The Victorian Minister for Housing, Disability and Ageing Martin Foley said the institute would focus on research, education, and training to attract more workers to both sectors as well as boosting the skills of the workforce. This is the first time a government, a tertiary institution and the social service sector has collaborated on such a project.

Supporting Students with Disability in NSW Public Schools - Audit Office of NSW Report

The Department of Education (the Department) is responsible for supporting students with disability in New South Wales public schools. It estimates over 91,000, or around 12 per cent, need help with their learning due to disability. This may include physical or intellectual disability, or disorders affecting communication or mental health. Around 80 per cent of these students are enrolled in regular classes in public schools, with the remaining enrolled in specialist support classes.

Conclusion: "Given the diverse needs of students with disability, the Department is doing a reasonable job in managing how well they transition to a new school and in supporting teachers to improve these students' educational outcomes. However, while some schools support students with disability well, others have more to do before they adequately meet students' needs. This is partly due to cultural resistance in schools, and the lack of expertise of some teachers, regarding disability.

There are many processes in place to help teachers identify and meet the needs of students with disability when they transition to a new school. Teachers use a range of strategies to tailor support to each student, including adjusting how they teach the curriculum and the use of learning aids. However, schools should provide clearer information on the support available at their local school and consult more with families on what is being done to address the needs of their child.

In recent years, the Department has implemented a range of initiatives to help teachers support students with disability, including extra training and putting disability resources into schools. However, some teachers feel they are still not effectively supported, particularly teachers in regular classes who may be less experienced in teaching students with disability. Many want more help to manage student behavior and support students with autism and mental health issues. Teachers and parents also said the negative attitude of some teachers towards disability is a barrier to improving outcomes for these students."

The Australian Government is developing an Integrated Plan for Carer Support Services to better support and sustain the work of unpaid carers.

The first stage of the Plan included design and implementation of Carer Gateway. Established in December 2015, Carer Gateway is a national website and contact centre that provides carers with practical information and support and helps them connect with local support services. An important second stage of the Plan involves developing a new integrated carer support service system through a co-design process. The purpose of the new service system is to deliver supports that reduce carer strain, increase carer well-being and support them to continue in their caring role. A draft Service Concept was developed through research, co-design workshops with carers, and input from subject matter experts and the Carer Gateway Advisory Group. The draft Service Concept sets out the types of services that could be delivered under a future service delivery model.

The role of private rental brokerage in housing outcomes for vulnerable Australians

This research explores Australian private rental brokerage programs which provide assistance in securing and sustaining private rental tenancies for disadvantaged tenants. The research identifies a diverse range of activities tailored to individuals and local circumstances, but lacking common terminology, measures and reporting making it difficult to assess the overall success of these programs beyond specific program outcomes.

Private rental brokerage programs (PRBPs) are a key pillar of support for disadvantaged people accessing and sustaining private rental. This is in addition to more formal private rental assistance programs delivered by state and territory governments; and Commonwealth financial assistance in the form of Commonwealth Rent Assistance and tax incentives to increase supply (e.g. NRAS).

Due to the diversity of private rental brokerage activities delivered primarily by non-government organisations in response to local needs, these various programs and activities have lacked a single visible identity. There is no one size fits all as these are tailored to individual needs however common activities include: information and referral; flexible individual support; promotion of self-reliance and resilience; working with landlords and real estate agents to broker tenancies; practical and material assistance, and post-housing support.

Key to the success of some of these programs are that tenants are 'rent ready' and that strong relationships with real estate agents are brokered, established over time and maintained by trust and confidence.

Access and barriers to online education for people with disabilities

This paper, Mike Kent of the **National Centre for Student Equity in Higher Education**, reports on a study conducted in 2014 and 2015 that explored the accessibility of eLearning for students with disabilities studying fully online in Australia. The study looked at students studying through Open Universities Australia (OUA). OUA brings together 15 different independent higher education institutions to teach students fully online across a number of different fields. This diversity of institutions allowed a number of different eLearning environments, technologies and learning and teaching strategies to be canvassed.

The findings of this research indicated that student with disabilities found that online study through OUA was a preferred way to access higher education. There was an unexpectedly high incidence of students with a mental illness (44.9% of survey respondents) and medical impairments (39.2% of survey respondents), with mobility impairments rounding out the top three categories (25.3% of survey respondents). The finding of this prevalence was one of the major findings of this study, along with the impact of different impairments on learning technologies, learning and teaching strategies and attitudes towards disclosure. The report presents a number of recommendations related to policy and compliance, staff training, unit design, and assessment design and implementation. It also calls for further directions for research including the development of universal design in eLearning, and the need for further research to provide a voice for staff at universities in relation to access for students with disabilities.

Around 250,200 more jobs are expected over the five years to November 2020 (up by 16.4%). Nearly four in five workers in Health Care and Social Assistance have completed post-school study. The research aimed to increase understanding of the impact of the structural adjustment and contribute an evidence base to guide governments and their agencies, participants and carers, and respite services on action they may take during the transition that could maximise stakeholder benefit and minimise negative impact. Living Well: A Strategic Plan for Mental Health in NSW 2014-2024

The Strategic Plan sets out actions and future directions for reform of the mental health system in NSW. It maps a demanding agenda for change that puts people – not processes – at the heart of its thinking. It asks that the NSW Government recommit to completing the process of reform begun with the Inquiry into Health Services for the Psychiatrically III and Developmentally Disabled (Richmond Report) in the 1980s in particular by taking two important steps - closing the remaining stand-alone psychiatric institutions and shifting the focus of mental health care from hospitals to the community.

The Plan does not directly govern the operation of services but instead lays out directions and principles for reform which agencies and service providers must find ways to embed in the supports they offer to people in our community.

The Report and the Plan are companion documents and should be read together.

Disability, Ageing and Carers, Australia: First Results, 2015

2015 Australian Bureau of Statistics Survey of Disability, Ageing and Carers (SDAC) presents key information about disability prevalence in Australia as well as data about older Australians (those aged 65 years and over). Data is also included about people with disability who reported that they had experienced discrimination.

- There were 4.3 million Australians with disability, that's nearly one in five people (18.3% of the total population).
- After removing the effects of different age structures, the age standardised disability rate for all people was 17.0%. This compares to 17.4% in 2012 and 17.7% in 2009.
- Of the 15.4 million Australians living in households who were of working age (15 to 64 years), there were
 over two million people with disability, that's one in seven people.
- Just over half (50.7%) of Australians aged 65 and over reported living with disability.
- Some 5.8% of all Australians had a profound or severe disability. After removing the effects of different age structures, the age standardised rate was 5.5%.

Medicare-subsidised mental health-related services

- Almost 10 million Medicare-subsidised mental health-related services were provided by psychiatrists, GPs, psychologists and other allied health professionals to over 2 million patients in 2014–15. This represented an average of 5 services per patient over the year.
- GPs provided more services to more patients than the other provider types.
- There has been an average annual increase of 6.0% in the total number of Medicare-subsidised mental health-related services recorded for the 5-year period from 2010–11 to 2014–15. Clinical psychologist services had the highest average annual increase (10%) over the period.
- Females were more likely than males to access Medicare-subsidised mental health-related services from psychiatrists (54%) were females, general practitioners (62%), clinical psychologists (62%), other psychologists (61%), and other allied health providers (62%).

In 2014-15, around 333,800 people used disability support services under the National Disability Agreement (NDA), including around 1,900 who transitioned to the National Disability Insurance Scheme (NDIS) during the year. Many (44%) had an intellectual or learning disability, more than half (52%) lived with their families, and close to one-third (30%) of those aged 15 and over were not in the labour force. The KPIs for Australian mental health services have been developed to improve accountability and transparency at the Mental Health Service Organisation (MHSO) level. The 15 indicators aim to address the Health System Performance tier of the National Health Performance Framework by monitoring performance within public MHSO.

- 41.4% of admissions have a preceding community contact
- 41.7% of clients are new clients (within the last 12 months)
- 14.1 days is the average length of stay in acute inpatient units
- 6.8 days is the average number of community treatment days per 3 month period of ambulatory care
- \$1,061 is the average cost per day in general acute inpatient units
- \$305 is the average cost per community treatment day
- 72.4% of people who receive inpatient care get significantly better
- 13.7% of people are readmitted within 28 days
- 66.4% of patients leaving acute inpatient care are followed up within 7 days
- 37.7% of mental health inpatients episodes are comploeted.
