#### Scheme almost doubles - 61,000 Australians now in the NDIS

More than 61,000 Australians are now participants in the National Disability Insurance Scheme (NDIS) with an approved plan. The NDIS Quarterly Report, covering the period from 1 October to 31 December 2016, shows the number of participants in the Scheme doubled to 61,000 in six months with strong growth in the last quarter. The Scheme grew by more than 25,000 people between October and December last year, with 23,494 participants receiving an NDIS plan and 2267 children referred through the NDIS Early Childhood Early Intervention (ECEI) approach, which is available to children under six years of age who have a disability or developmental delay. ## NSW Government Transfers All State Disability Community Support Teams to NGO

To support the roll out of the NDIS, the NSW Government is transferring all of its disability services to the non-government sector by July 2018.

The Benevolent Society will be the new provider of all our FACS community support teams across NSW. Community support teams include case managers, occupational therapists, speech pathologists, physiotherapists, behaviour support staff, dietitians, psychologists, nurses and therapy assistants. They're all highly skilled and dedicated professionals, have a great reputation across the disability sector. To provide continuity of care for our clients and to retain a capable and experienced workforce, clinical services staff and staff who directly support clinical services will transfer to the Benevolent Society. It is expect that the transfer will start from August 2017.

Minister for Disability Services Ray Williams said the Benevolent Society has been chosen after an extensive and competitive selection process. "The Benevolent Society is an exceptionally strong service provider with a great track record as Australia's first charity. For more than 200 years they have supported Australians to live their best life," he said. "They have an impressive plan to grow and expand the business, and a proven record in delivering supports to children, young people and adults with disability. Their safety and continuity of service throughout the transfer remains the priority." Other key factors in the decision were the Benevolent Society's strong existing footprint in NSW, and ability to integrate clinical services into its business.

Benevolent Society CEO Jo Toohey said the organisation was well positioned to integrate clinical services, with the appropriate business systems, quality and risk management frameworks and resources to enable a successful transition. "We aim to transform the specialist disability clinical services into a leading centre of excellence that is known for its research, practice development, clinical expertise and sector development to achieve better outcomes for people with disability." "Our strong focus on culture and people will ensure clients and staff are well supported," Ms Toohey said.

## Cause of death and potentially avoidable deaths in Australian adults with intellectual disability using retrospective linked data

The deaths of more than 700 Australian adults with an intellectual disability could have been avoided with more appropriate health care and monitoring, a UNSW study by Julian Trollor, Preeyaporn Srasuebkul, Han Xu and Sophie Howlett. has revealed.

The studies objective was to investigate mortality and its causes in adults over the age of 20 years with intellectual disability (ID) [who were registered users of Disability Services in NSW and therefore people with mild ID maybe under-represented]. The ID cohort comprised 42,204 individuals who registered for disability services with ID as a primary or secondary diagnosis from 2005 to 2011 in New South Wales (NSW). The Comparison cohort was obtained from published deaths in NSW from the Australian Bureau of Statistics (ABS) from 2005 to 2011. Cause of death in ID cohort was dominated by respiratory, circulatory, neoplasm and nervous system. After recoding deaths previously attributed to the aetiology of the disability, 38% of deaths in the ID cohort and 17% in the comparison cohort were potentially avoidable.

The conclusion was that adults with ID experience premature mortality and over-representation of potentially avoidable deaths. A national system of reporting of deaths in adults with ID is required. Inclusion in health policy and services development and in health promotion programmes is urgently required to address premature deaths and health inequalities for adults with ID.

## Intellectual Disability, Australia

In 2012 there were around 668,100 Australians (2.9%) with intellectual disability.

intellectual disability was most common in the very young and very old, with prevalence rates of 4% for children aged 0-14 years and 10% for people aged 75 years and over.

the rates of intellectual disability were higher for men (3.3%) than for women (2.6%).

The difference was particularly marked for boys aged 0-14 years who were twice as likely to have intellectual disability than girls in the same age group.

young boys in this age group were 3.6 times more likely to have Autism or a related disorder than girls (50,500 boys compared with 13,900 girls).

There are many causes of intellectual disability including genetic conditions, problems during pregnancy, problems at birth and health problems during childhood as well as conditions that occur more commonly in later life, such as dementia.

many people had an intellectual disability as a result of a head injury (32,600 people), stroke (35,900 people), or other brain damage (31,100 people).

The most commonly reported main condition causing intellectual disability was "intellectual and developmental disorders" (88,200 people). Some of the other reported conditions included Dementia (86,500 people) and Autism and related disorders (including Rett's syndrome and Asperger's syndrome) (84,800 people).

## Research into Maximising Life Choices of People with a Spinal Cord Injury.

Spinal Cord Injuries Australia (SCIA) recently commissioned the Social Policy Research Centre at the University of New South Wales to carry out research about maximising life choices of people with spinal cord injury (SCI). SCIA really wanted to understand what the main things are that are stopping people who experience a SCI from being fully involved in all aspects of society. As our organisation's Vision is all about "a society without barriers for people with a SCI", we really need to do everything we can to understand what these barriers are, so we can do whatever it takes to remove them.

## Mental health-related prescriptions

This section presents information on <u>prescriptions</u> for mental health-related <u>medications</u>. Mental health-related medications reported here cover antipsychotics, anxiolytics, hypnotics and sedatives, antidepressants, and psychostimulants and nootropics—prescribed by all medical practitioners.

Information for mental health-related prescription is sourced through the Pharmaceutical Benefits Scheme (PBS) and the Repatriation Pharmaceutical Benefits Scheme (RPBS).

#### Key points

- There were 35.3 million prescriptions for mental health-related medications dispensed (subsidised and under co-payment) in 2014–15. This equates to an average of 9.0 prescriptions per patient in 2014–15.
- There were a total of 24.8 million prescriptions for subsidised mental health-related medications in 2014–15, which was 7 in 10 (70.1%) of the total number of mental health-related prescriptions.
- 86.8% of the mental health-related prescriptions (subsidised and under co-payment) were provided by GPs, with 8.0% being prescribed by psychiatrists and 4.6% by non-psychiatrist specialists.
- Antidepressant medications accounted for 67.8% of total mental health-related (subsidised and under co-payment) prescriptions.
- Females, those aged 65 and over and those people living in *Inner regional* areas had the highest mental health-related prescription and patient rates.

A Key Performance Indicator (KPI) is a measure that describes a situation concisely, helps track progress and performance and acts as a guide to inform decision making. This qualification reflects the role of workers in the community and/or residential setting who follow an individualised plan to provide person-centred support to people who may require support due to ageing, disability or some other reason. Work involves using discretion and judgement in relation to individual support as well as taking responsibility for own outputs. Workers have a range of factual, technical and procedural knowledge, as well as some theoretical knowledge of the concepts and practices required to provide person-centred support. To achieve this qualification, the candidate must have completed at least 120 hours of work as detailed in the Assessment Requirements of the units of competency.

#### Certificate IV in Mental Health CHC43315-01V02

This qualification reflects the role of workers who provide self-directed recovery oriented support for people affected by mental illness and psychiatric disability. Work involves implementing community based programs and activities focusing on mental health, mental illness and psychiatric disability. Work is undertaken in a range of community contexts such as community based non-government organisations; home based outreach; centre-based programs; respite care; residential services, rehabilitation programs; clinical settings; or supporting people in employment. Work is carried out autonomously under the broad guidance of other practitioners and professionals.

To achieve this qualification, the candidate must have completed at least 80 hours of work as detailed in the Assessment Requirements of units of competency.
