Disability support services: services provided under the National Disability Agreement 2015-16

In 2015-16, an estimated 332,000 people used disability support services under the National Disability Agreement (NDA), including around 3,500 who transitioned to the National Disability Insurance Scheme (NDIS) during the year.

- * The average age of service users was 35, and around three-quarters (72%) were aged under 50.
- * Forty-three per cent of service users had an intellectual or learning disability, 42% had a physical or diverse disability, 29% had a psychiatric disability, and 18% had a speech or sensory difficulty.
- * Almost one-third (30%) of service users aged 15 and over were not in the labour force. Of those in the labour force, two-thirds (67%) were unemployed.
- * Two-thirds of service users had an informal carer, most often their mother (73%). Around one in eight (12%) service users had an informal carer who was aged 65 and over.

'Superagency' to oversee NDIS quality

An independent authority with broad ranging powers will be created next year to oversee the \$22 billion National Disability Insurance Scheme, the government announced in Tuesday's budget. The new NDIS Quality and Safety Commission will have national responsibility for implementing the scheme's Quality and Safeguarding Framework,

The Budget allocated \$209 million over four years to operate the body that will:

- monitor the safety of the scheme's anticipated 460,000 participants
- register NDIS providers and monitor their compliance with national standards
- · handle complaints and
- respond to reportable incidents such as abuse
- oversee and enforce a new national code of conduct for all workers, and
- issue penalties for breaches of the code
- have an education role to help eliminate restrictive practices in the industry such as the use of physical restraints.

The new watchdog is slated to commence on 1 January 2018 and replace state-based regulatory systems as the NDIS becomes fully operational in each jurisdiction by 2020.

The new code of conduct for workers will cover all workers providing services under the NDIS, including to self-managing clients who directly employ their own staff.

NDIS will be fully funded with a Medicare Levy

The Budget includes a measure to increase the Medicare levy by 0.5% from July 2019 which will provide funding of \$9.1 billion for the NDIS over the forward estimates. The long term funding of the NDIS has been an issue of contention between the major parties. Despite this tension, it remains clear that there is strong bi-partisan agreement and commitment to the full funding and progression of the NDIS.

The Government announced \$209 million to establish an independent NDIS Quality and Safeguards Commission

Australians are living longer, and their state of health in these years has important implications for population health and wellbeing and for Australia's health and care systems.

- Between 2003 and 2015, life expectancy at birth increased for both sexes, and most of this increase
 corresponded with an increase in years living free of disability and free of severe or profound core activity
 limitation.
- Older Australians have also seen increases in the expected number of years living free of disability.

<u>Timed Light Therapy for Sleep and Daytime Sleepiness Associated With Parkinson</u> Disease A Randomized Clinical Trial

Aleksandar Videnovic, MD, MSc; Elizabeth B. Klerman, MD, PhD; Wei Wang, PhD; et al. Light therapy may be a feasible intervention for improving sleep and alertness in patients with Parkinson's Disease. In this randomized clinical trial of 31 participants with Parkinson's Disease and coexistent excessive daytime sleepiness, light therapy administered twice daily for 2 weeks was well tolerated and resulted in significant improvements of excessive daytime sleepiness and several other metrics of sleep and Parkinson's Disease severity. Burden of lower limb amputations due to diabetes in Australia: Australian Burden of Disease Study 2011

The Australian Burden of Disease Study (ABDS) 2011 captured four complications of diabetes-diabetic neuropathy, diabetic foot ulcer, lower limb amputation, and vision impairment-and their prevalence and burden were estimated.

This bulletin presents findings from the ABDS on the burden of diabetes-related lower limb amputations in Australia.

- In 2011, it was estimated that about 730,000 Australians had diagnosed diabetes, 1.7% (12,300) of whom experienced lower limb amputation.
- The health loss experienced as a direct result of diabetes-related lower limb amputation accounted for about 1% of total non fatal burden estimated for diabetes in 2011. This represented 456 years of healthy life lost due to living with disability in Australia.
