## NDIS Now Available Throughout NSW

NSW continues to lead Australia in transitioning to the National Disability Insurance Scheme (NDIS) with it rolling out across the State today, announced Minister for Disability Services Ray Williams.

This is an important milestone for people with disability in NSW, who have previously not had access to the Scheme, to have more choice and control over their supports. "At last, people with disability throughout the State are at the centre of decision-making and are empowered to live the life they choose," Mr Williams said. "More than 90 per cent of participants are satisfied with the Scheme in the State. We will continue to work hard with participants and the sector to deliver an NDIS people with disability deserve."

Mr Williams said the NSW Government will also continue to provide information to people with disability, their families and carers to help them prepare for the NDIS. "We are committed doing everything we can to ensure people are ready to take advantage of all that the NDIS can deliver."

More than 54,000 people with disability have already joined the NDIS in NSW, with a further 60,000 expected to join in 2017-18.

## NDIS specialist disability accommodation: pathway to a mature market

The Pricewaterhouse Coopers Consulting (Australia) and Summer Foundation report states that "the current status of the disability accommodation market is fragmented and underfunded. As a result, it is an inflexible market where consumers have limited choice in their housing options."

One of the most important tasks for the NDIS is to create more housing for people with disability, especially for young people living in aged care. Specialist Disability Accommodation (SDA) payments are the mechanism the NDIS is using to stimulate the creation of this housing. This report aims to provide the information necessary to see the SDA market grow. It shares our vision of what a mature SDA market will look like, highlights five different types of market players involved and shares lessons learnt from the growth of other markets. ## **NDIA Gets New CEO as Construction Begins on Head Office**

The former managing director of Bankwest, Rob De Luca, has been announced as the new CEO of the National Disability Insurance Agency, on the same day the "first sod" was turned on the site of the new headquarters in Geelong.

Social Services Minister Christian Porter congratulated De Luca on his appointment and said he would guide the National Disability Insurance Scheme during a "critical transition to full roll out across Australia" over the next three years. "During Mr De Luca's time as managing director, Bankwest invested significantly in improving the experience for its one million customers."

The announcement comes as construction on the NDIA's new headquarters officially got underway. The new building is set to house 560 staff responsible for delivering the \$22 billion National Disability Insurance Scheme to 460.000 Australians.

## **New Disability Innovation Institute**

Disability researchers at UNSW Sydney are putting the finishing touches to a ground-breaking initiative to help transform the lives of people with disability by harnessing research and innovation across all faculties and disciplines.

The Disability Innovation Institute at UNSW, to be launched this year, will be a platform to combine disability studies with STEM (Science, Technology, Engineering and Medicine) and HAS (Humanities and Science) research to design accessible and inclusive working, living and learning environments, generate innovative technologies and create inclusive law, policy, services, markets and communities.

The interdisciplinary institute will collaborate with people with disability to identify, understand and research solutions to the practical challenges experienced by people with disability. A Disability Inclusion Maker's Exchange will connect scholars, makers and users to develop long-lasting solutions to the practical challenges experienced by people with disability.

About one in five Australians -4.2 million people or 18.5% of the population - identify as having a disability. That number will likely to grow as Australia's population ages, with one in two people predicted to develop an age-related disability over the next 20 years.

SPRC's Professor Karen Fisher says innovation is stimulated by unexpected connections and by necessity.

"Disability is one area where this happens," Fisher says. "But these innovations can have the potential for a much wider impact and use across society. Smart home technology is a good example. Another is electronic voting, which was developed for accessibility but is now extending to the rest of the electorate."

## Service users' perspectives on having choice and control in the new NDIS

A Melbourne Social Equity Institute research team recently embarked on a project to explore the degree to which the NDIS is achieving its aims and objectives from the perspective of people with disability using these services.

Introduced in 2013, the National Disability Insurance Scheme (NDIS) is the most significant reform of disability services in Australia in a generation. The scheme aims to increase both the funding available for disability services and the control that people living with disabilities have over the design and delivery of their care. It does this, in part, by handing greater control over care budgets to people with disabilities and their families so that services might be designed and delivered in a way that better meets their particular needs. With Australia recently ranked last in an OECD study of quality of life of people with disabilities, and with the significantly worse outcomes experienced by people with disabilities, the NDIS is a welcome reform.

The research team took a novel approach to the research process, which is participatory in nature involving community researchers with disabilities working with university-based experts. Involving people with disabilities in the research process improved the quality of the project in terms of our ability to collect and analyse evidence effectively.

#### NDIA ILC National Readiness round 2

The National Disability Insurance Agency (NDIA) has opened the second Information, Linkages and Capacity Building (ILC) National Readiness Grants round.

The NDIA will be accepting applications in Activity Area One of the ILC Policy - **Information**, **linkages and referrals** <a href="https://ilctoolkit.ndis.gov.au/about-ilc/main-components-ilc">https://ilctoolkit.ndis.gov.au/about-ilc/main-components-ilc</a>.

Up to \$25.3 million (inc. GST) is available in 2017-18, and up to \$4.7 million (inc. GST) is available in 2018-19 to support these ILC activities. Organisations will be able to apply for grants funding of up to 2 years.

## Public Guardian and the National Disability Insurance Scheme (NDIS)

When the Public Guardian is appointed with a services or advocacy function we will consent to the represented person becoming an NDIS participant. The Public Guardian will advocate for the participant's reasonable and necessary support needs, both current and future, to be built into their NDIS plans. ## The role of Private and Enduring Guardians within the NDIS

If you are a private or enduring guardian for a person eligible for the NDIS you should contact the NDIA to let them know you are the legally appointed guardian. You can contact the NDIA on 1800 800 110. You should also let service providers know you are the legally appointed guardian. In your role as guardian you may be asked to provide consent for the person under guardianship to access NDIS funding. ## Psychiatric disability support services 2015-16

About 96,300 people with a psychiatric disability made use of disability support services in 2015–16, at a rate of 402.4 per 100,000 population (or about 1 in 250 Australians). Psychiatric disability was the most frequently reported primary disability among people receiving non-residential disability support services, and the second most frequently reported for residential disability support services. The rate of non-residential service users with a psychiatric disability was 400.3 service users per 100,000 population in 2015–16; this was relatively stable between 2011–12 and 2015–16 (with an average annual increase of 0.9%). In contrast, the rate of residential service users (15.0 per 100,000 in 2015–16) decreased by an annual average of 2.5%. Group homes were the most frequently used service type by people with a psychiatric disability receiving residential services in 2015–16.

This Australian Institute of Health & Welfare web site section presents information on specialist disability support services, provided under the <u>National Disability Agreement (NDA)</u> to service users with a <u>psychiatric disability</u> either as their <u>primary disability</u> or as an <u>other significant disability</u>. Unless otherwise stated, service users with psychiatric disability include all service users with psychiatric disability, regardless of whether it is considered a primary or other significant disability.

## Expressions of Interest for Supported Temporary Accommodation in NSW

In 2017/18 the NSW Government is making up to \$10 million available to non-government organisations (NGOs) to provide Supported Temporary Accommodation through an Expression of Interest (EOI).

Temporary Accommodation (TA) is a critical component of the NSW Government's response to homelessness. It provides a safety net and ensures, wherever possible, that a person experiencing homelessness can be accommodated on any given night.

In 2016/17 FACS supported over 24,800 homelessness clients with TA. Over time the number and complexity of

clients have increased and there is now clear recognition within both FACS and the NGO sector that TA could play a greater role in providing support as well as shelter to those experiencing homelessness.

EOIs are now open for South West Sydney, Illawarra, and Southern Highlands, with other NSW regions to follow.

# Crowdfunding and charities: Information for charities, donors and fundraisers about the use of crowdfunding

Crowdfunding is an increasingly popular method of online fundraising for individuals, businesses, not-for-profits and charities. Generally it involves an individual or an organisation setting a fundraising target online and then asking the crowd of the internet for donations to reach that target. Crowdfunding provides fundraisers with an opportunity to communicate with, and potentially receive funds from, a wider audience than they would ordinarily have access to. Similarly, it also provides donors with a way to donate directly to a wider range of causes from all over the world. Although crowdfunding has the potential to provide great benefits for charities and donors, there are some aspects of the practice that people need to consider before embarking on a campaign or donating to a cause. ## Current NDIS can't provide decent jobs, researchers warn

A research team led by UNSW's <u>Social Policy Research Centre</u> (SPRC) has examined the ability of the National Disability Insurance Scheme (NDIS) to provide decent jobs for disability support workers and sounded a warning on the developing problem of NDIS pricing.

According to their report, "Reasonable, Necessary and Valued", the pricing system does not cover the full costs of disability support and will fail to provide high quality services.

Key findings of the report on NDIS pricing arrangements include:

- Disability support workers are not allocated enough work time required to provide personalised, coordinated, responsive and safe services to people with disability.
- The legal employment entitlements of disability support workers can't be met.
- Casualisation is contributing to financial insecurity for workers.
- Pricing doesn't include training or further skills development of the disability support workforce.
- Disability support workers are accessing important training in unpaid time.
- Unpredictable shifts are leading to poor work-life balance.
- Physical injuries, exhaustion, stress and other negative psychological impacts arise from the combination of unsafe working conditions and high work intensity.

## Social security and welfare spending in Australia: assessing long-term trends

This brief by the Tax ad Transfer Policy Institute draws mainly on OECD data from 1980-2014 and on Australian Bureau of Statistics (ABS) data about social security payments to households. When spending trends are adjusted for data improvements, it can be estimated that spending on social security increased from 6.1% of GDP in 1980 to a peak of 8.1% of GDP in 1993. The peak is due to the effects of the deep recession at the time. Spending on social security then fell back to 6.2% of GDP immediately before the Global Financial Crisis (GFC) in 2007-08.
