New NDIS team to solve payment delays after providers left out of pocket

There have been reports of practices closing because of delays in NDIS payments.

Most NGOs who have previously had state funded clients transfer to the NDIS and state funding ceasing, have been **owed substantial amounts of money by the NDIS for prolonged periods of time.**

The National Disability Insurance Scheme (NDIS) is dedicating a team of more than 20 staff to resolve payment delays experienced by providers, after a number of concerns raised in the past six months.

From January 29 to February 4, the NDIS indicated 21,810 payments had been unsuccessful, and 14,086 of those were because the "claim amount was greater than the available service booking". National Disability Services chief executive Ken Baker, who represents the non-government sector, said delays were likely to be because a person's plan had expired and there was not a new plan in place, so there was not a booking against which a claim could be made.

The NDIA's Independent Pricing Review has been released. The report by McKinsey & Company details 25 recommendations – all of which the NDIA has endorsed in principle. When implemented the report's recommendations will certainly provide some relief for providers and reduce the risk of market failure. However, disappointingly, the report does not accept that the standard one-to-one support price is based on flawed assumptions. NSW Government Commits to Disability Advocacy Funding

New South Wales disability advocates have breathed a "collective sigh of relief", after the state government back flipped on plans to cut funding for disability advocacy groups. NSW Premier Gladys Berejiklian and Minister for Disability Services Ray Williams announced that up to \$26 million would be available for advocacy services until 2020. The current funding for disability advocacy services in NSW was set to expire on 30 June 2018, and the state government had earlier indicated that they would no longer fund specific disability advocacy services under the full scheme National Disability Insurance Scheme. NDIS needs market help to deliver shortfall in specialist disability housing

Funding for Specialist Disability Accommodation (<u>SDA</u>) under the National Disability Insurance Scheme (<u>NDIS</u>) is expected to support 28,000 people, 6 per cent of all NDIS participants. However, the NDIS has provided limited information about the demand for this specialist housing. Now a newly published <u>study</u> has found the existing supply of SDA needs to grow by 60 per cent to house the 28,000 people the NDIS expects to fund.

The report identified another 33,200 people with very high support needs who "may require SDA on top of the 17,500 already in this form of housing. Of these 33,200 people, 6,200 people are under 64 residing in aged care."

NDIS providers facing pressure meeting demand

Uncertainty and low prices are driving the fact that supply is not keeping up with demand. Less than half of disability service providers surveyed for the State of the Disability Sector Report 2017 could meet all demand and the outlook for 2018 suggests the supply gap will continue to widen with only 43 per cent, compared to 53 per cent in 2016, expected to meet demand. More alarmingly, one in 10 is considering pulling out of providing services to the disability sector entirely. "The reality is that many suppliers are providing a broad range of services, not just disability, such as mental health and childhood services, support, so the barriers to entering and exiting the disability sector are quite low." Spinal Cord Injury Australia Reports

Spinal cord injury from traumatic causes imposes a heavy physical, psychological and economic burden on the injured people, their families and society, because it often results in a high level of long-term disability and morbidity and in increased mortality risk. This Australian Institute of Health and Welfare collection of reports provides data from 2008-09 to 2013-14 on the incidence of traumatic spinal cord injury, the people injured, the care provided to them, and the causes of the injuries. The latest report shows that in 2013-14, 236 new incident cases of spinal cord injury due to external causes were reported to the Australian Spinal Cord Injury Register. Males accounted for 81% of traumatic spinal cord injury cases. Land transport crashes (46%) were the leading mechanism of injury followed by falls (32%). Nearly half (45%) occurred while the person was engaged in a sport or leisure activity.

ACNC Public trust and confidence in Australian charities 2017: market research report

Previously conducted in 2013 and 2015, this research and subsequent report aims to understand the changes in the general public's attitudes and beliefs regarding trust and confidence over time. The majority of Australians have engaged with the charity sector in the past year. Charitable support was based on the knowledge there would be a clear and measurable outcome and an understanding that a high proportion of funds donated would contribute towards the cause. This is particularly important, as Australians recognise the positive contribution and influence charities have on society.

Australians donate to charities primarily for the perceived importance of the cause, the 'feel good' factor and a sense of duty to provide for those less fortunate. Nine in ten Australians claim to have had some involvement with a charity in the past year (91%),including donating time, money or goods. The primary driver of support is the importance of the cause –two thirds (65%) donate for this reason. Over four in five Australians (83%) will engage in some form of action or research when donating money. This might involve claiming a tax refund (56%) or researching if they are donating to a valid charity(34%). Australians think it is highly important for a charity to disclose information regarding donation use (76%), proportions spent on the cause (72%) and outcomes achieved (69%). Older Australians (those aged 55+ years old) are more likely than their younger counterparts to have high levels of trust. Despite availability of many new antiepileptic drugs with differing mechanisms of action, outcomes in newly diagnosed epilepsy have not improved; developing new disease-modifying compounds to current add to seizure-suppressing drug treatments may be necessary. The Joint Protocol to reduce the contact of people with disability in supported accommodation with the criminal justice system aims to reduce unnecessary contact with the Police in relation to incidents that would be better managed within the disability accommodation service, and to improve relationships and communication between local police and disability services.
