# Administration of reviews under the National Disability Insurance Scheme Act 2013

Report on the National Disability Insurance Agency's handling of reviews by the Commonwealth Ombudsman's Office

This report is based on information extracted from complaint investigations, stakeholder feedback, briefings provided by the NDIA, and the legislation, policy and procedural guidance relevant to the administration of reviews under the National Disability Insurance Scheme Act 2013.

Between July 2016 and January 2018, the Office of the Commonwealth Ombudsman received 400 complaints that were, at least in part, about the NDIA's administration of reviews. This represents 32.5 per cent of all complaints made to our Office about the NDIA during this period.

Of particular concern is the issue of delays in completing reviews. In February 2018, the NDIA advised our Office it had around 8,100 reviews on hand, and it was receiving around 620 new review requests each week. The NDIA has acknowledged some reviews are taking up to nine months to be completed.

While the NDIA implemented a new dedicated national team in November 2017 tasked with addressing the backlog, to date this approach has not been adequate to quickly and effectively work through the outstanding requests. As of 30 January 2018 (12 weeks after the commencement of the backlog team), the NDIA had triaged around 3,400 requests and completed around 1,500 reviews.

Without significant efforts to improve the timeliness of NDIA's administration of reviews and communication with participants, there remains a risk that participants' right to review will be undermined and review processes will continue to lack fairness and transparency and continue to drive a high volume of complaints.

# **Evaluation of the NDIS: final report**

The main objective of the evaluation of the NDIS by the National Institute of Labour Studies, Flinders University, Department of Social Services (Australia) has been to offer a well-informed and independent assessment of the many impacts of the NDIS trial. The trial has taken place in South Australia (SA), Tasmania (TAS), New South Wales (NSW), Victoria (VIC), the Australian Capital Territory (ACT) and the Barkly region in the Northern Territory (NT). This consolidated report contains findings based on all data collections undertaken over the course of the evaluation, including surveys and interviews with NDIS participants, their families and carers, disability support providers, and other stakeholders. Several main findings emerge from the evaluation of the NDIS. The first finding is that the Scheme has been designed and built on sound fundamentals. This is an important confirmation of the policy. # **NDIS Funding**

**People with Disability Australia** (PWDA) welcomes the Federal Government's commitment to its share of the National Disability Insurance Scheme (NDIS) so that people with disability have the services and supports they need and deserve. "We hope that this now ends the uncertainty for people with disability, the ongoing political debate and the cuts to social security and services as trade-offs for NDIS funding," said Therese Sands, Co-CEO of PWDA. "We will be holding all sides of government to account for the clear statement in the Budget papers that the NDIS is fully funded, now and into the future."

"Although we need to see the detail, we welcome the \$92 million over five years that will assist people with disability who are not eligible for the NDIS to continue to receive support under Commonwealth programs."

### PRO BONO AUSTRALIA NDIS: Disability Sector Welcomes NDIS Funding Commitment

The disability sector has welcomed the federal government's commitment to fully fund the National Disability Insurance Scheme, and called for attention to now be turned to fixing the scheme's implementation issues. Treasurer Scott Morrison announced in his federal budget speech that the NDIS would be fully funded now and into the future. "Every dollar and every cent committed to delivering the National Disability Insurance Scheme remains in place and always will," Morrison said. "Any future treasurer should be clear that the NDIS is not a political football. It is a source of security for people with disability and their families who have enough uncertainty in their lives. Long-term certainty for the NDIS is imperative."

The budget also contained some other NDIS related funding measures.

This includes \$92.1 million to ensure continuity of support for those not eligible for the NDIS, \$9.9 million for Disability Employment Service (DES) providers to transition to a new reformed DES system and \$64.3 million to

establish an NDIS Jobs and Market Fund to expand the NDIS workforce and service providers. The government said the disability workforce would need to more than double from 73,000 full-time equivalent jobs in 2013 to about 162,000 jobs by 2020, when the scheme is expected to be fully rolled out.

Dr Ken Baker, CEO of **National Disability Services**, said he was pleased the government had revealed an alternative plan to ensure the NDIS's funding into the future was beyond doubt.

"In budget the government has been true to its word in finding another way to fund the NDIS. This scheme is too important to hundreds of thousands of Australians not to be fully funded – and it's clear the government agrees," Baker said.

### Hot Topic: Explainer - How Much Does the NDIS Cost and Where Does This Money Come From?

In wake of the ongoing debate about how the National Disability Insurance Scheme will be funded, Associate Professor Helen Dickinson explains how much the NDIS costs and where the money will come from, in this piece which first appeared in The Conversation.

The Productivity Commission <u>now estimates</u> that around 475,000 people with disability will receive individualised support at a cost of around A\$22 billion per year. Last year's <u>Productivity Commission review of costs</u> found the NDIS was broadly coming in on budget. The NDIS budget is estimated to gradually increase over time to 1.3 per cent of GDP by 2044-45 as participants age. Estimates also suggest the scheme will produce benefits adding around 1 per cent to the GDP.

The way the NDIS is funded is complex, with revenue coming from a number of sources. The NDIS is funded via a pooled approach from Commonwealth and state and territory governments. The Commonwealth provides <u>just over half</u> of the funding for the NDIS and the rest comes from state and territories. At the creation of the scheme, all existing money spent by various governments was directed into the NDIS to cover costs. Any additional funding the NDIS needs has to come from general budget revenue or borrowings. The treasurer announced tax receipts were running <u>A\$4.8 billon</u> higher than was estimated in December, meaning the levy was no longer needed.

# Breakthrough in autism spectrum disorders

People living with autism spectrum disorder are one step closer to receiving personalised genetic diagnosis and treatment, according to University of Queensland (UQ) research. New approaches in genomic technologies, computational models and experimental systems could potentially lead to personalised treatment based on an individual's genetic composition, UQ Diamantina Institute biologist, Dr Alex Cristino said. "Researchers were making significant progress in understanding the molecular mechanisms of complex genetic disorders such as autism."

Autism is caused by a 'perfect storm' of complex combinations of common and rare genetic variations and the disorder forms from unique combinations of both inherited DNA variations and spontaneously generated genetic errors, also known as de novo mutations. "Genetically speaking, there are many ways to develop autism. In most cases, no single genetic alteration or arrangement causes the disorder," Dr. Alex Cristino said.

Firstly, there is this section about SDA Prices and the introduction of the term "Price Limits". Wait a minute, what? Price Limits?

On choice and control – the document states "It is important for providers to note that an SDA budget to support a single resident dwelling is only likely to be provided to a very small number of SDA eligible participants (a small percentage of NDIS participants overall), even when the dwelling is in a configuration that makes shared supports possible." It outlines that most people will be assessed to live with 1 to 4 others with shared supports.

There is no information on who has SDA in their plans, where are they and against what criteria they were assessed. Now with this document, there are so many new contradictions, new terminology, new risks, new uncertainties that have been introduced. This seems to be in direct conflict with what this 'briefing' was supposed to offer.

#### **New NDIS Practice Standards**

The National Disability Insurance Scheme (Provider Registration and Practice Standards) Rules 2018 outline the registration requirements for providers under the NDIS. They also cover the new NDIS Practice Standards and the Quality Indicators that must be met in order to provide services. There is a huge amount of detail in these Rules released by Commissioner Designate of the NDIS Quality and Safeguards Commission, Mr Graeme Head and the Minister for Social Services, the Hon. Dan Tehan.

### What are the New Practice Standards and Quality Indicators?

The standards and indicators are underpinned by a rights based approach, choice and control and person centred practice. Yay! They also emphasise strong governance and risk management. Organisations delivering support will need to develop these processes and systems, and for higher risk services, staff will be interviewed to ensure they are imbedded in the organisation. The good news for most existing providers is that many will already be familiar with a lot of the quality indicators as they already have to meet similar existing State based quality standards.

### STAFF SCREENING Changes to the Crime Act Implications for Providers

The <u>Crimes Amendment</u> (National Disability Insurance Scheme – Worker Screening) Bill 2018 passed both houses of Parliament on 10 May. Consistent with the changes being rolled out under the Quality and Safeguarding Framework, this amendment is an important change for providers to be aware of. A person engaged by a registered NDIS provider to deliver NDIS supports that entail more than incidental contact with a person with disability, or in a key executive, management and operational position, such as a Chief Executive Officer, Chairman or Board Member, will be required to obtain an NDIS Worker Screening Check. # Prisoners with Disability Subject to Harrowing Abuse, Report Finds

# Research into the commission-based charity fundraising industry in Australia

This Australian Competition and Consumer Commission report examines commission-based fundraising in the Australian charity sector. Commission-based charity fundraising is a channel that has long been used by charities to obtain donors. The practice typically involves an individual fundraiser approaching members of the public on the street or at a public location (shopping centre, railway station, etc.) or moving from door-to-door and knocking uninvited, then attempting to sign-up donors. A variant of this practice involves a member of the public being contacted by an unsolicited telephone call to agree to a donation to a charity. There is concern that street, door-to-door or telemarketing approaches are associated with higher levels of public detriment. This is because of the particular characteristics commonly associated with this marketing approach - for example, its unsolicited nature and the high-pressure tactics that may be employed by some individual fundraisers. For this reason, commission-based charity fundraising has generally been subject to a greater degree of media scrutiny than some other channels. # Spinal cord injury, Australia 2014-15

In 2014-15, 264 newly incident cases of traumatic spinal cord injury (SCI) due to external causes were reported to the Australian Spinal Cord Injury Register. Males accounted for 4 in 5 (80%) of traumatic SCI cases. Land transport crashes (42%) were the leading mechanism of injury for cases of traumatic SCI sustained in 2014-15, followed by falls (40%).
