National screening system to protect NDIS participants

Minister for Families and Social Services, Paul Fletcher, said the *National Disability Insurance Scheme Amendment* (Worker Screening Database) Bill 2018, introduced into the Federal Parliament 13 February 2019, would establish a national database to support a nationally consistent approach to screening people who work with NDIS participants.

The new approach to NDIS Worker Screening is due to start in July 2019 in all States and Territories, except Western Australia. Western Australia intends to join the national scheme from July 2020.

"Worker screening is a way to check that people who are working, or seek to work, in the NDIS do not pose an unacceptable risk of harm to people with disability," Mr Fletcher said. "The effect of the Bill will be to establish a nationally consistent worker screening approach following extensive work by the Department of Social Services, the NDIS Quality and Safeguards Commission, and State and Territory governments.

No "opt out" for NDIS Participants (article extracts)

The NDIS promises Participants an ordinary life, but the journey to get there is far from an ordinary experience. Lee Archer explores what Participants are forced to share about themselves in order to access the supports they need.

The concept of privacy as a right for consumers and citizens of Australia isn't always awarded the same seriousness for people with disability. For some people, the NDIS planning process and provider engagement has increased the privacy intrusion into their everyday life that **would not be acceptable to most Australians.**

The experience of formulating an 'ordinary life' through the NDIS can be a far cry from an 'ordinary' experience, especially when compared to how Australians access other supports and services. If the NDIA are serious about an 'ordinary life,' then this needs to translate into an ethical approach to data collection. A person's goals, dreams, aspirations and identity are their own, not the NDIA's to grab.

Disability Services Fighting to Stay Afloat

Disability providers are struggling to meet the needs of their clients under the National Disability Insurance Scheme, according to a new report that warns the sustainability of the sector is at risk. The Centre for Social Impact's (CSI) Latest report examined National Disability Services' Annual Market Survey and found the disability sector continued to be characterised by disruption due to the NDIS rollout.

It said the **financial position of many providers was becoming more precarious**, noting that compared to previous years **more providers were operating at a loss** – 28 per cent compared to 21 per cent in 2016.

CSI research director, Associate Professor Gemma Carey, told Pro Bono News more market gaps would develop if providers dropped out of the scheme because they could not run a sustainable business.

"The qualitative results suggest that providers are struggling with **high administrative loads which are not covered by NDIS prices**," Carey said. "If organisations close due to financial instability, we are likely to see more market gaps emerge."

State of the Disability Sector Report 2018

Some Introductory Extracts:- "The NDIS has ushered in a new era for disability service providers. It can be like an ocean; sometimes stormy, with a dangerous undertow; at other times extending our horizons and carrying us forward. The challenge before us is how we navigate this journey of change and collectively create the best possible NDIS."

"Disability service providers support the NDIS reform principles. They welcome the major boost in funding in response to the chronic unmet need for services, the expansion of choice and control for people with disability and their families, the investment in early intervention, and the goal of equitable access to services across Australia. However, the road to reform is rough, and many service providers are under stress. Their sense of uncertainty is exacerbated by frequent process changes, inconsistent advice, new regulations and difficulty getting the market data they need to make growth decisions."

"At the core of NDS's 2018 State of the Disability Sector Report are findings from a survey of 626 service providers. They include providers of all sizes, from every state and territory, that collectively span the full range of disability service provision. Providers' experiences of the NDIS are mixed, but more than half see the operating conditions in the disability sector as worsening: 80 per cent say that the disability policy environment is uncertain."

"Providers are frustrated with NDIS systems and processes. Over the past year, many have experienced long delays in payments; the NDIS portal is not user-friendly; and the quality of NDIS plans is uneven. Providers are

expending unpaid effort on untangling red tape, resolving payment issues and helping people with disability to get plans that properly reflect their needs and goals. All of this imposes costs on providers at a time when they are under pressure to reduce their costs. The impact of very tight NDIS prices on service quality is a significant concern. Some of the prices stretch supervision ratios and don't allow for investment in staff training. They impede the recruitment and retention of experienced and qualified staff. While problems persist, the NDIS will not deliver on its great promise to Australians with disability."

The Centre for Social Impact (partners <u>University of New South Wales</u>, <u>Swinburne University of Technology</u>, <u>University of Western Australia</u>) National Disability Services' (NDS) Annual Market Survey is a key resource in understanding the state of the Australian disability sector, its challenges and opportunities. A key driver for this research is the introduction of the National Disability Insurance Scheme and the substantial restructuring of individual organisations and the supply-side of the scheme. This research is intended to identify risks, monitor change and identify any undesirable consequences occurring in the disability sector. While findings have been included in NDS's <u>State of the Disability Sector Report 2018</u>, the Centre for Social Impact is providing a long-form report for the sector.

Scammers sent fake NDIS Commission emails with the subject line 'NDIS Commission Compliance Review'. The email asks you to participate in a compliance review and attaches a 'Request for Service Records' form. It instructs the recipient to complete and return the information within 14 days of receipt. The email comes from a [.info] address but official NDIS Commission emails will always come from a [ndiscommission.gov.au] domain.

Report calls for better NDIS market management

A report says gaps in the NDIS marketplace are resulting in unfair and inequitable access to services for people with a disability and calls for better management of the national scheme. It highlights the need for better "market stewardship" to ensure equal access to NDIS services and fair and efficient distribution of resources, but concludes the scheme is currently ill-equipped to detect service gaps and other market deficiencies. The report from the UNSW Centre for Social Impact is the latest in a number of critical reviews calling for better stewardship of the NDIS. The report, National Disability Markets, says while the NDIS promises to improve the lives of more than 400,000 Australians the scheme has been marred by a "range of implementation challenges". The report, titled *Disrupted: The consumer experience of renting in Australia*, is the second of its kind commissioned by CHOICE, National Shelter and The National Association of Tenant Organisations (NATO), revealing rental issues with poor quality homes needing repairs, insecure tenancies and struggles with rental affordability. A survey of 1,547 renters revealed 16 percent of people with disability have been served with a no-grounds eviction, compared with nine per cent of the rest of the surveyors who rent. Patients with severe paralysis regain use of hands

Six people with severe spinal cord injuries have regained the use of their hands and fingers through a non-invasive spinal stimulation technique. The revolutionary treatment pioneered by Professor Reggie Edgerton and his team at UCLA enabled patients who had been paralysed for years, to turn doorknobs and open bottles for the first time since sustaining their injuries. This is the largest recovery of the use of hands that has been reported in patients with such severe spinal cord injuries.

Professor Edgerton, who is now also Professor of Spinal Cord Injury at the <u>University of Technology Sydney</u> (UTS), has bought this research to Sydney through <u>Project Edge</u>. Project Edge will be the first comprehensive scientific and clinical research program outside the US. Funding permitting, The UTS Centre for Neuroscience and Regenerative Medicine, where the trials will be held.

Program Looks to Halve Electricity Costs for Charities

Charities have the chance to slash their power bills by up to 50 per cent through an energy-efficiency program set to expand across Australia. Electricity company EnergyAustralia's Power for Good program will complete energy audits of participating charities to identify how they can use energy more efficiently, and then install batteries, solar panels, and smart energy management systems for these organisations. As more charities join, EnergyAustralia expects the program will eventually create one of Australia's largest "virtual power plants", whereby thousands of solar and battery systems are linked and managed remotely. Can infections in childhood trigger the development of neuropsychiatric disease? A study by Köhler-Forsberg et al¹ in this issue of *JAMA Psychiatry* provides strong epidemiologic evidence that severe infections, as well as exposure to antiinfective agents, place children and teenagers at greater risk for developing neuropsychiatric illnesses. By studying Danish medical records from more than 1 million individuals, the team found that the risk of developing mental disorders in children (age 18 years or younger) was increased by more than 80% after a hospitalization for severe infection. Association of Dementia With Mortality Among Adults With Down Syndrome Older Than 35 Years

Rosalyn Hithersay, MSc; Carla M. Startin, PhD; Sarah Hamburg, PhD; et al. In a longitudinal study including 211 adults with Down syndrome 36 years and older, 27 people died during follow-up (mean, 28; range, 1-65 months), and dementia was the proximate cause of death in 70% of cases. Crude mortality rates were 5 times higher in those with dementia than those without. JAMA Neurol. <u>Evaluation of Differences in Temporal Synchrony Between Brain Regions in Individuals With Autism and Typical Development</u>

Jace B. King, PhD; Molly B. D. Prigge, PhD; Carolyn K. King, BA; et al. In this cohort study of 52 individuals with autism and 38 typically developing participants and a replication study of 1402 participants in a brain imaging database, increased durations of functional connections in autism were found in both distributed networks and individual brain regions, which were associated with metrics of disease severity. Persistence of brain connectivity in autism may limit the ability to rapidly shift from one brain state to another and contribute to the pathophysiology of autism. Clinical Utility of Reinterpreting Previously Reported Genomic Epilepsy Test Results for Pediatric Patients

Jeffrey A. SoRelle, MD; Drew M. Thodeson, MD; Susan Arnold, MD; et al. In this study of reported genetic variants from clinical genomic epilepsy tests, 67 of 185 pediatric patients (36.2%) had variants reclassified. A clinically significant change in the interpretation occurred in 19 of 61 patients (31.1%) with a genetic diagnosis during the 5-year study. The findings of this study suggest that pediatric patients with epilepsy and previous genomic test results should have their test results reinterpreted at least every 2 years and before further genetic testing.
