#### NDIS risks failure without urgent intervention

Australia's disability service providers warned that many are at risk of failure unless the government acts to fix ongoing problems with the National Disability Insurance Scheme (NDIS).

NDS President, Joan McKenna-Kerr, said providers launched a paid media campaign in the lead-up to Federal Budget to call on the government and opposition to deliver on their bipartisan promise to make the NDIS a great social reform. Ms McKenna-Kerr warned that many not-for-profit disability service providers are already being forced to cut services as a direct result of systemic flaws in the way the NDIS is being implemented. "In particular, we are finding providers reluctantly withdrawing one-on-one care services because the delivery models are just not viable," she said. "This is leaving those participants in the scheme with the most profound challenges, finding it harder to find the care they need."

Providers are calling for a new independent pricing body, urgent improvements to the way the NDIS is administered, less red tape, better NDIS planning, market failure safeguards and a National Workforce Strategy to support the sector in delivering the scheme.

NDS Acting CEO, David Moody, warned that if the sector experiences market failure, the NDIS could collapse, leaving almost half a million Australians with disability without services.

According to research conducted by NDS:

- 1 in 10 disability service providers have discussed closing
- 28% of service providers made a loss or deficit; and
- more than half (54%) of Australian disability providers say they will have to reduce the quality of services under the current pricing model.

"Our members helped lead the campaign for the NDIS and we continue to support it 100 per cent as a vital reform for Australians with disability," Mr Moody said. "However as a direct result of the way the NDIS is being administered, more than half of our members have foreshadowed they will reduce the quality of services unless NDIS pricing better reflects the cost of actually delivering services." #### Advocates ask, why are NDIS funds not being used to fix the scheme?

Disability groups have welcomed the federal government's \$528 million pledge for the disability royal commission but say a multi-billion dollar underspend of National Disability Insurance Scheme funds in the budget is a

"national disgrace". Matthew Bowden, co-CEO of People with Disability Australia, said this budget funding was very much welcomed, noting that a variety of supports were needed to allow people to fully participate. The almost \$4 billion underspend of NDIS funds is a national disgrace, and we completely oppose the spending of these funds anywhere but on people with disability," he said. "People with disability come to us every day in despair because they can't access the NDIS, their funding packages have been cut or they aren't getting the supports they urgently need. # NDIS A suite of changes to pricing is being introduced

This Newsflash details four important changes to ensure service providers are able to provide high quality supports to NDIS participants:

- Increased prices for therapy services following finalisation of the Pricing Review of Therapy Services
- Increased prices for attendant care supports
- A new Temporary Transformation Payment to see providers through this period of transition
- An NDIS Demand Map and Transition Funding to help providers plan and grow their business

With the establishment of the NDIA Pricing Reference Group (PRG), the NDIA's approach to pricing combines an increased rigour in decision making through consultation with providers and adaptation to market pressures. One of the ways this is evident is the NDIA's use of market reviews, which feed into the Annual Price Review cycle.

The NDIA will introduce significant price limit increases to therapy and base attendant care supports effective 1 July 2019.

The Federal Government has today announced an increase to price limits for therapy, attendant care and community participation under the National Disability Insurance Scheme (NDIS), effective 1 July 2019. These price increases will inject more than \$850 million into the NDIS market in 2019-20 so that NDIS participants can access the quality and innovative services and supports that meet their individual needs.

Minister for Families and Social Services, Paul Fletcher, and Assistant Minister for Social Services, Housing and Disability Services, Sarah Henderson said the new prices include a minimum increase of almost \$11 per hour for therapists and up to a 15.4 percent price increase to the base limit for attendant care and community participation. ### **NDIA CEO Robert De Luca QUITS**

The NDIA board was informed of Robert De Luca's immediate exit on Tuesday 30 April, and quickly moved to appoint deputy CEO Vicki Rundle as acting head of the organisation that manages the National Disability Insurance Scheme.

The appointment of a new CEO will be decided by the incoming government following the federal election on 18 May.

De Luca quit the NDIA to become CEO of Zenitas Healthcare – a NDIS provider which lists the scheme as its - second-largest revenue source – and it is understood his immediate departure was to avoid a conflict of interest.

# **Understanding Specialist Disability Accommodation funding**

This Australian Housing & Urban Research Institute study examined the Specialist Disability Accommodation (SDA) program and the attitudes of industry to investment and participation in that program. It questioned developers, investors, housing providers, prospective tenants and governments on how the SDA program will generate new supply that meets the needs and preferences of people with disability. This Social Ventures Australia and the Summer Foundationreport provides a snapshot on how the Specialist Disability Accommodation (SDA) market is responding to the opportunity to expand housing supply for people with disability. #### Rental affordability snapshot 2019

Every year, Anglicare Australia tests if it is possible for people on low incomes to rent a home in the private market. We do this by taking a snapshot of the thousands of properties listed for rent on realestate.com.au. We test whether each property is affordable and suitable for people low incomes.

This year we surveyed over 69,000 rental listings across Australia and found that there is a chronic shortage of affordable rentals across Australia: **only 317 out of 69,000 rentals were affordable for a single person on the Disability Support Pension (i.e. 0.002%)** Access the Anglicare Australia report <u>here</u>.

### Estimating need and costs of social and affordable housing delivery

This University of NSW: City Futures Research Centre report presents the findings of a research project commissioned by CHIA NSW and Homelessness NSW to provide estimates of the social and affordable housing need for Australia by sub-region and the likely costs to government of delivering housing to meet these needs over the period to 2036. The unmet social housing need is estimated to be 437,000 while the unmet affordable housing need is estimated to be 213,000.

#### People with disability want budget investment of \$2.7 billion to solve housing crisis

PWDA, with the Summer Foundation, National Shelter, and the Australian Network for Universal Housing Design, have developed a package to address the housing crisis for many people with disability. The package includes measures to make more homes accessible, to increase the supply of affordable and social housing, and reform the Specialist Disability Accommodation funding in the NDIS. People with disability are being forced into group homes and aged care, can't find an accessible place to live, and are struggling to afford a home. # Simpler process to improve NDIS Assistive Technology

National Disability Insurance Scheme (NDIS) participants will find it easier to replace their Assistive Technology (AT) to enable them to continue to pursue their goals following the introduction of simpler processes. Minister for Families and Social Services, Paul Fletcher said replacement for standard AT items will be quickly assessed by the National Disability Insurance Agency (NDIA) without needing a full re-assessment, and will only require one quote for items valued between \$1,500 and \$15,000. The Australian-American Fulbright Commission offers scholarships to Australian citizens across all career stages. Awardees take part in an academic and cultural exchange, pursuing research or study at a U.S. institution, experiencing life abroad and bringing back their knowledge and experience to share with their communities in Australia.

A Fulbright award is more than a scholarship – it is, in the words of Senator Fulbright, a means of fostering "leadership, learning, and empathy between cultures… It is a modest program with an immodest aim – the achievement in international affairs of a regime more civilised, rational and humane than the empty system of power of the past."

#### The categories are:

**Postgraduate:** Fulbright Postgraduate Scholarships allow postgraduate students undertaking their Australian PhD to conduct research in the U.S. for 3 months up to 2 years.

#### or

Supports enrollment in a graduate degree program (e.g. a Master's) for 3 months up to two-years.

**Postdoctoral**: Fulbright Postdoctoral scholarships allow individuals to undertake postdoctoral research in the U.S. for 3-10 months, who have completed their PhD in the past 5 years or are in the last year of completion. **Scholar**: Fulbright Scholar Awards are for academics (at Associate or full Professorial level) and mid-career professionals (with an undergraduate qualification and minimum 10 years work experience) to undertake research and/or training in the United States for 3-4 months.

**Distinguished Chair:** The Fulbright Distinguished Chair award is for an exceptional individual at professorial level to carry out research in the United States for up to 6 months.

#### Mental Health Matters: Future Investment Priorities for NSW Report.

The report recommends targeted investment which would improve the lives of people living with mental health conditions and would be cost-effective by driving down escalating presentations to emergency departments. Specifically, the report recommends additional funding of \$180 million for HASI and CLS type supports, \$88 million to establish 600 step-up,step-down places and improved community access to mental health services through community mental health hubs. #### Mental Health Safety & Monitoring Review Report.

MHCC considered it timely to examine the function and effectiveness of safeguarding and monitoring mechanisms across community-managed mental health services. With funding from NSW Health, Mental Health Branch, MHCC set out to investigate whether there is a need for the sector to have further or changed safeguarding and monitoring in the light of transforming service delivery environment. The project undertook analysis, informed by consultations and a Landscape Review, in order to outline the national and NSW policy context and document the safeguarding and monitoring mechanisms that apply to CMOs providing psychosocial supports in NSW. The project sought to identify the implications of national and state reforms for mental health CMOs in NSW that are registered NDIS providers, as well as for those who are not. Furthermore, to explore and document examples of international and other states' models of safeguarding and monitoring for CMOs providing psychosocial supports; and draw tentative conclusions to be tested through further research and consultation. #### **Policies & Guidelines**

#### Aged Care: Single quality framework: focus on consumers

The Australian Government is committed to high quality care for older Australians and considers the health, safety and welfare of aged care recipients a high priority. As part of reforms to the aged care system, the government is developing an end-to-end, market-based system with the sector where the consumer drives quality. This includes a Single Aged Care Quality Framework. There are currently four sets of quality standards depending on the type of aged care service being delivered. The new Standards are now set in law, and providers will be assessed and monitored against these new standards from 1 July 2019. These will be replaced by the new Aged Care Quality Standards.

#### Prevalence and Severity of Alzheimer Disease in Individuals With Down Syndrome

Michael S. Rafii, MD, PhD; Stephanie L. Santoro, MD. The median life expectancy for a child with Down syndrome (DS) born in the 1950s was less than 10 years of age, with congenital heart defects being the main cause of death. With advances in medical care and improvements in the overall health of individuals with DS, life expectancy has increased dramatically; for children with DS born in 2010, median life expectancy is estimated to be 65 years. However, along with this longer lifespan comes the prospect of a considerable increase in the risk of developing dementia associated with Alzheimer disease (AD), with a prevalence of nearly 80% for those with DS who are older than 65 years. #### Long term Risk of Neuropsychiatric Disease After Exposure to Infection In Utero (Autism & depression)

Benjamin J. S. al-Haddad, MD, MSc, PhD¹; Bo Jacobsson, MD, PhD²,³; Shilpi Chabra, MD¹; et al. In this Swedish population-based cohort study of 1,791,520 children born between 1973 and 2014 (up to 41 years), exposure to infection, including urinary tract infection, in pregnancy significantly increased the risk for autism spectrum disorder and depression, but not bipolar or psychosis, during the child's life. These results emphasize the importance of avoiding infections during pregnancy, which may impart subtle fetal brain injuries contributing to development of autism and depression. JAMA Psychiatry. # <u>Patterns of Nonsocial and Social Cognitive Functioning in Adults With Autism Spectrum Disorder: A Systematic Review and Meta-analysis</u>

In this systematic review and meta-analysis of 75 studies comprising 3361 individuals with autism spectrum disorder and 5344 neurotypical adults, those with autism spectrum disorder showed the greatest impairments in theory of mind and emotion perception and processing, followed by processing speed and verbal learning and memory. The severity of impairments across domains of nonsocial and social cognition in adults with autism spectrum disorder identified highlight key intervention targets and suggest significant implications for clinical practice. # <u>Association of Autism Spectrum Disorder With Prenatal Exposure to Medication Affecting</u> **Neurotransmitter Systems**

Higher estimates of autism spectrum disorder risk among the offspring of mothers taking certain medications during pregnancy are most likely not owing to pharmacologic effects of those drugs. In 2015–16, 253 newly incident cases of traumatic spinal cord injury (SCI) due to external causes were reported to the Australian Spinal Cord Injury Register. Males accounted for 80% of traumatic SCI cases. Almost half (48%) of the traumatic SCI cases sustained in 2015–16 were due to a fall. A further 39% were due to a land transport crash. # <u>Association of Maternal Prenatal Vitamin Use With Risk for Autism Spectrum Disorder Recurrence in Young Siblings</u>

Rebecca J. Schmidt, PhD; Ana-Maria Iosif, PhD; Elizabeth Guerrero Angel, MS; et al. In this cohort study of 241 younger siblings of children with autism, the prevalence of autism spectrum disorder was 14.1% in children whose mothers took prenatal vitamins in the first month of pregnancy compared with 32.7% in children whose mothers did not take prenatal vitamins during that time. Maternal daily intake of prenatal vitamins during the first month of pregnancy appears to be associated with reductions in recurrence of autism in high-risk families; additional research is needed to confirm these results, to further investigate specific nutrients, and to inform public health recommendations for autism spectrum disorder prevention.
